Patrick and Kathryn Townsend, and Anneke Jensen, are appealing the Hearing Examiner's Decision dated February 17, 2017, and Decision on Reconsideration dated March 13, 2017, which approved the request of a Shoreline Substantial Development Permit to develop an intertidal geoduck aquaculture operation on private tidelands located at 930 – 76th Avenue N.W., in Thurston County.
